### Notes:

- if the movement (debit) the account is not paid for during a calendar month, and no fee is charged for maintaining the account for the current month;

- additional services and fees for them that are not provided for in this tariff are listed in the tariff plan "Additional services", which are an integral part of this tariff plan.
- the Bank does not provide for the execution of the client's orders (payment order) on paper.
- the Commission fee is charged and debited in the national currency - "sum".
- \* account maintenance fee is charged every month for the first debit transaction;
- \* the prepaid Commission for account maintenance by the Bank is not refunded, if the terms of service are terminated;
- \*\* at the request of the client, the interest is charged to the balance of the client's main / secondary account in national currency for the month. Interest is paid at the end of each current month;
- \*\*\* the free limit on payments within the tariff includes a quantitative or total indicator
